Spirits entries for Ultimate Spirits Challenge (USC) 2015 will be judged by category on a rolling deadline and evaluated in our own, specially designed evaluation center in New York. We are accepting entries now.

Because we believe that in today's world, spirits can only be properly assessed if they are examined both neat and mixed in a cocktail USC is expanding the spirits evaluation process to **examine how individual spirits perform in a category-appropriate cocktail**. (No cocktail rating where not appropriate – for example, flavored vodkas, liqueurs.) The assigned cocktail for each category will change each year, thus renewing our commitment to cocktail evaluation.

No US importer? No problem! We will take care of the necessary US Customs documentation. You must not ship until we have provided the documentation.

Included in this entry form package is the form, an example page in case you're not sure how to enter the name, category code numbers, a check list to make sure you've not forgotten anything, and a shipping label.
